Are there services covered before you meet your deductible ?	No.	You will have to meet the deductible before the plan pays for any services.
Are there other deductibles for specific services?	Yes. \$100 /member or \$300 /family for Prescription Drugs . There are no other specific deductibles .	You must pay all of the costs for these services up to the specific deductible amount before this plan begins to pay for these services.
What is the out-of-pocket limit for this plan ?	\$2,500 /single or \$5,000 /family for In- Network Providers . The out-of-pocket limit is the most you could pay in a year for covered services.
