### Course Description:

This class is for emergency response personnel who are required by the National Incident Management System (NIMS) to complete the I-300 and I-400 levels of ICS to be in compliance. The curriculum in the course is recognized by the National Wildfire Coordinating Group (NWCG), the California Standardized Emergency Management System (SEMS), and the NIMS Integration Center (NIC). This course focuses on ICS activities during major incidents at the **field level**. It is **not** a train-the-trainer course.

Organization and Staffing	Command and General Staff	Unified Command
Resource Management	Air Operations	Area Command
Incident and Event Planning	Field to Local Government Coordination	Mutual Aid

### Prerequisites:

Participants must provide documentation of completion of ICS I-100 and I-200 prior to attending.

**Tuition: FREE** These courses are funded by the Emergency Management Performance Grant (EMPG) for California State and local government agencies including National Guard, schools, and non-profit organizations. Private industry, out-of-state organizations, Native American Tribes, and Federal Government employees are eligible if they are a part of a California local or state government emergency management response/recovery effort.

ICS 300-400 courses are elective courses available for individuals seeking to complete the Governor's Office of Emergency Services' **Emergency Management Specialist Training Certificate Program**.
